The undersigned JONAS MARTING does hereby make, subscribe, acknowledge and files these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The names of this corporation shall be SUN FIN COMMUNICATION, INC.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted is import/export business.



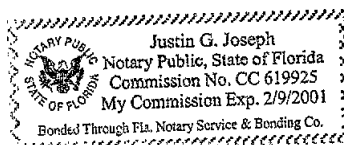
