The name of this corporation shall be Lawton Brothers Painting of Orlando, Inc.

ARTICLE II. DURATION

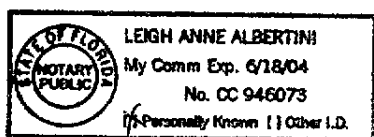
