CERTIFICATE OF INCORPORATION

OF

We undersigned, hereby associated curselves together for the consumption of becoming a corporation under the laws of the State of Florida by and under the provisions of the statutes of the State of Florida, providing for the formation, rights, privileges, immunities and liabilities of incorporation for profit.

ARTICLE I

The name of the corporation shall be: SKY MEDIA, INC.
