The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### <u>ARTICLE I</u>

#### Corporate Name and Principal Office

The name of this corporation is WORKFORCE OF SOUTH FLORIDA, INC. and its principal office and mailing address is 1000 N. Ashley Drive, Suite 600, Tampa, FL 33602.

#### ARTICLE II

#### Commencement of Corporate Existence

The corporation shall come into existence on the date of filing with the Florida Secretary of State.

#### ARTICLE III

#### General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.
