I received none of the previous mailings mentioned on this form. I have since inquired as to whether my attorney or my accountant received them and neither reports having seen them.

I am afraid that, as has happened with some other documents, they were lost in the many "forwardings" of our mail. We have moved back and forth between our former home in Massachusetts and Sarasota several times during the year in the process of relocating, preparing our house for sale, etc. and had the Post Office forward our mail each time. Other documents have never reached us and apparently the same thing happened to the Department of Corporations documents.

I have enclosed the conventional \$150 filing fee in hopes that you will accept that this delay was not due to my ignoring the notices, but due to not having received them.
