ARTICLE I - NAME

The name of the corporation is SHREE GEE OF PANAMA CITY, INC.

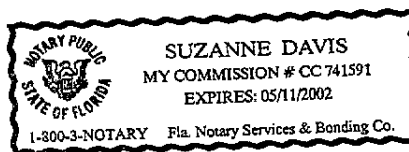
