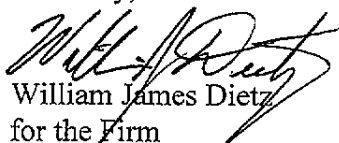

In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I CORPORATE NAME.

The name of this corporation is Global Document Imaging, Inc.

ARTICLE II PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation are 109 Durham Place, Longwood, Florida 32779.

ARTICLE III EXISTENCE

The existence of the corporation shall begin on December 15, 2000.

ARTICLE III CAPITAL STOCK.

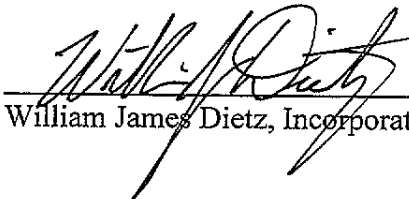

DESIGNATION OF REGISTERED AGENT AND ACCEPTANCE

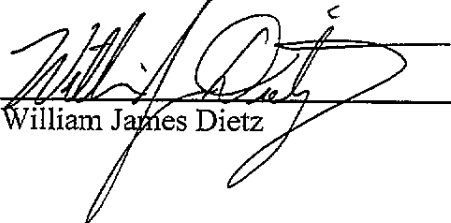
