ARTICLES OF SHARE EXCHANGE OF COMPUTERIZED TRAFFIC DATA, INC., A FLORIDA CORPORATION WITH PEGGY MALONE & ASSOCIATES, INC., A FLORIDA CORPORATION

ARTICLES OF SHARE EXCHANGE between Computerized Traffic Data, Inc., a Florida corporation ("CTD") and Peggy Malone & Associates, Inc., a Florida corporation ("PMA").

PLAN OF SHARE EXCHANGE

This Plan of Share Exchange ("Plan") is entered into between Computerized Traffic Data, Inc., a Florida corporation ("CTD") and Peggy Malone & Associates, Inc., a Florida corporation ("PMA").

Distribution To Shareholders. On the Effective Date, all of the shareholders Article 1. of CTD not dissenting from the Plan will exchange all of the issued and outstanding stock of CTD for sixty-seven (67) shares of PMA, and CTD will become a wholly owned subsidiary of PMA.

Article 4. Filing With the Florida Secretary of State and Effective Date. Upon the closing, as provided in the Agreement and Plan of Share Exchange, of which this Plan is a part, PMA and CTD will cause their respective presidents to execute Articles of Share Exchange in the form attached to this Plan, and upon such execution, this Plan will be deemed incorporated by reference into the Articles of Share Exchange as if fully set forth in such Articles of Share Exchange. Thereafter, the Articles of Share Exchange will be delivered for filing to the Florida Secretary of State, and the date of filing will be the Effective Date.
