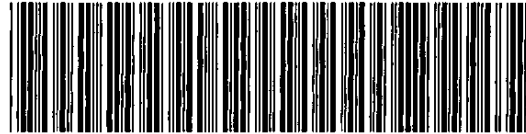



SECOND: The document number of the corporation is P0000011629.


THIRD: The Dissolution was authorized on January 24, 2008.
