ARTICLE I-NAME

The name of this Corporation shall be JET BUILDERS, INC..

ARTICLE II-DURATION

The Corporation shall have perpetual existence commencing January 2, 2001

ARTICLE III-PURPOSE

The Corporation is formed for the purpose of transacting any and all lawful business.

ARTICLE IV-CAPITAL STOCK

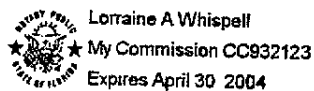


