The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

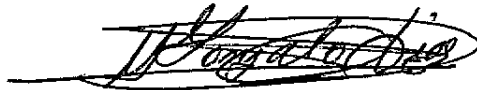
ARTICLE XI INFORMAL ACTION OF DIRECTORS

AMENDMENTS OF ARTICLES**

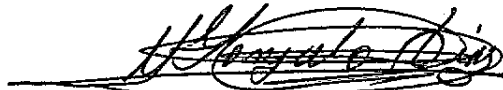

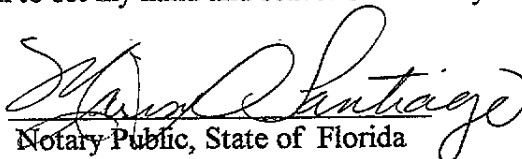

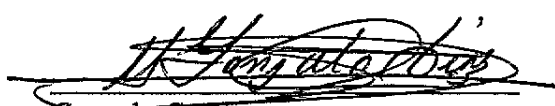
