

**ARTICLES OF INCORPORATION**

*The undersigned incorporator(s), being an individual duly licensed to render antique sales and service, hereby form a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.*

**ARTICLE I. CORPORATE NAME.**


