OF

ARTICLE I - NAME

The name of the corporation formed pursuant to these Articles of Incorporation is Luxury Flush Services, Inc.

ARTICLE II - DURATION

The corporation shall exist perpetually, commencing on the date of the filing of the Articles of Incorporation.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, *Florida Statutes*.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 10,000 shares of \$.01 par value common stock.


