ARTICLES OF INCORPORATION OF CHANDAN VIDEO & ENTERTAINMENT, INC.

PARCE PARCE

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is CHANDAN VIDEO & ENTERTAIN-MENT, INC.
