ARTICLES OF INCORPORATION OF HILL'S CLEANING SERVICE, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is Hill's Cleaning Service, Inc. The principal place of business of the corporation is 15177 Park Side Dr. #5, Ft. Myers, Fl. 33908. The mailing address of the corporation is 15177 Park Side Dr. #5, Ft. Myers, Fl. 33908.
