3. The corporation shall have the authority to issue 1,000 shares of common stock, in one class only, each with a par value of \$ 0.001.


4. The registered agent of the corporation is Fred E. Weaver and the registered address is 4358 Twin Lakes Drive, Melbourne, Florida 32934-7116.
