ARTICLES OF INCORPORATION OF SOFAS & SEATS, INC.

SEGRESS PHIC. 24 The undersigned, for the purpose of forming a corporation fo profit under the laws of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I Name

The name of the corporation is SOFAS & SEATS, INC.

ARTICLE II Principal Office

The principal office and mailing address of the corporation shall be 3080 Airline Blvd., Portsmouth, Virginia 23701

ARTICLE III Duration

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, except that if they are not filed by the Department of State of the State of Florida within five (5) days, exclusive of legal holidays after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

ARTICLE IV Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V Capital Stock

- (a) Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is One Thousand (1000) shares of common stock having a par value of \$.01 per share.
- <u>Preemptive Rights</u>. Shareholders shall have no preemptive rights.

- (c) <u>Cumulative Voting</u>. Cumulative voting shall not be permitted.
- (d) <u>Restrictions on Transfer of Stock</u>. The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer or encumbrance of the stock of this corporation as they may see fit.

ARTICLE VI Initial Registered Office and Agent

The name and street address of the initial registered office of this corporation is UCC Filing & Search Services, Inc., 526 E. Park Avenue, Tallahassee, Florida 32301.

ARTICLE VII Directors

- (a) <u>Number</u>. This corporation shall have one (1) director(s) initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one.
- (b) <u>Initial Directors</u>. The name and street address of the members of the first board of directors of the corporation are:

- (c) <u>Compensation</u>. The shareholders of this corporation shall have the exclusive authority to fix the compensation of directors of this corporation.
