# ARTICLES OF INCORPORATION OF ADE & SCHILDBERG, P.A.

ARTICLE I.

NAME

The name of this corporation is ADE & SCHILDBERG, P.A.

ARTICLE II.

#### **PURPOSE**

This corporation is organized for the purpose of rendering professional legal services and engaging in and transacting all other business not in conflict with said purpose as may be permitted under the laws of the State of Florida.

#### ARTICLE III.

## PROFESSIONAL CORPORATION RESTRICTIONS

#### ARTICLE IV.

### PRINCIPAL OFFICE

#### ARTICLE V.

#### COMMENCEMENT OF EXISTENCE
