ARTICLES OF INCURPOS.

OF

BAY AREA BAIL BONDS AND INVESTIGATIONS, INC.

The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms and proporation (the "Corporation") under the laws of the State of Florida, as follows:

#### ARTICLE II **Term of Existence**

EFFECTIVE DATE 01-01-01

The date when corporate existence shall commence shall be January 01, 2001, and the Corporation shall have perpetual existence thereafter.

#### ARTICLE III **Nature of Business**

The Corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

#### ARTICLE IV Powers

The Corporation shall have power:

- (a) To have perpetual succession by its corporate name:
- (b) To sue and be sued, complain, and defend in its corporate name in all actions or proceedings;

- To lend money to and use its credit to assist its officers and employees to the full extent (f) permitted by law;
- (g) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of and otherwise use and deal in and with. shares or other interests in, or obligations of, other domestic or foreign corporations. associations, partnerships or individuals, or direct or indirect obligations of the United States or of any other governmental state, territory, governmental district, or municipality or of any

instrumentality thereof;

- (h) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income;
- (i) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested;
- (j) To conduct its business, carry on its operations, and have offices and exercise the powers granted by the Florida General Corporation Act within or without the State of Florida;

- (p) To be a promoter, incorporator, general or limited partner, member, associate, or manager of any corporation, partnership, joint venture, trust or other enterprise;
- (q) To have and exercise all powers necessary or convenient to effects its purposes.

#### ARTICLE V Capital Stock

# ARTICLE X Indemnification

## ARTICLE XI Preemptive Rights

Each shareholder of the Corporation shall have the first right to purchase shares (and any securities convertible into such shares) of any class, kind or series of the Corporation's capital stock that may from time to time be issued, whether or not presently authorized, including treasury shares, in the ratio that the number of shares such shareholder holds at the time of issuance bears to the total number of share then outstanding, exclusive of treasury shares. A shareholder may also waive his or her preemptive rights by affirmative written notice of waiver within thirty (30) days of receipt of notice of the Corporation's issuance of shares.
