ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or 621, F.S. (Profit)

ARTICLE I NAME

The name of the corporation shall be JBP INTL, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- 1. The corporation shall have unlimited power to engage in and to do any lawful act concerning any or all lawful business for which corporations may be incorporated under Florida Chapter 607, as amended, under the provisions of which the corporation is incorporated.

 - c. To borrow money and give security therefore.

- d. To enter into, make, perform and carry out contracts of every kind of any lawful purpose pertaining to its business, with any individual, entity, firm, association or corporation, or with any government, municipality or public authority, domestic or foreign.
- e. To do everything necessary, proper, convenient or incidental to the accomplishment of the corporation or which is calculated directly or indirectly to promote the welfare or interests of the corporation or enhance the value or render profitable any of its property rights.
- f. To do any and all of the things in this article set forth to the same extent any natural person might or could so do and in any part of the world as principal, agents, contractors, trustees, or otherwise, either alone or in the company with others.
- 3. Specifically, but not in limitation of, all retail and wholesale carpet sales, marble sales, floor covering sales and any other associated activity.

ARTICLE IV DURATION

The period of its duration is perpetual.

ARTICLE V SHARES

This corporation shall have authority to issue 50,000 shares of common stock, and each share shall have a par value of \$1.00. A stock subscription agreement can be initially authorized.
