The undersigned, desiring to form a Corporation under the Laws of the State of Florida, hereby certifies as follows:

**FIRST:** The name of the Corporation shall be: **NATIONAL BUILDING JANITORIAL, INC.**

**SECOND:** The Corporation shall commence existence upon having its Articles of Incorporation filed by the State of Florida.

**THIRD:** The purpose for which this Corporation will be formed as follows: to engage in and transact any or all lawful business for which a Corporation may be incorporated under Chapter 607 of the Florida Statutes.

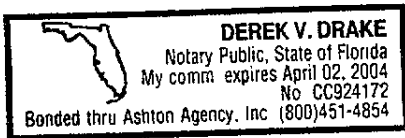
