

ARTICLES OF INCORPORATION

OF

SuperCue Corporation

ARTICLE I - Name

The name of this corporation is **SuperCue Corporation**.

ARTICLE II - Principal Place of Business

The principal place of business of this corporation is 13371 88th Place North, Seminole, Florida 33776.

ARTICLE III - Duration

This corporation shall have perpetual existence.

ARTICLE IV - Purpose


