The number of shares of stock that this corporation is authorized to have outstanding at any time is 100.

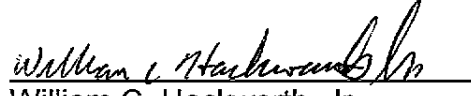

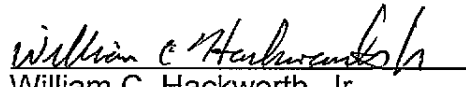

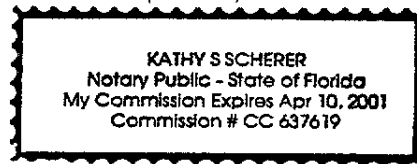
