The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME: The name of corporation shall be 100 W. Lucas Road, Inc.



ARTICLE VI INITIAL DIRECTOR: The sole initial director of the corporation is Matthew F. Kermish.


