ARTICLES OF INCORPORATION

OF

I, the undersigned incorporator, for the purpose of forming a corporation under Florida law, hereby adopt the following Articles of Incorporation:

ARTICLE I:

NAME

The name of the corporation shall be:

PURPOSE

ARTICLE IX: MANAGEMENT/AFFILIATION
