ARTICLES OF INCORPORATION OF FCB INTERIM BANK

TALECTON AM 10:5>

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be FCB Interim Bank and its initial place of business shall be 8375 Southwest State Road, 200, in the City of Ocala, in the County of Marion, and the State of Florida.

ARTICLE II

This corporation shall be organized as a successor institution in accordance with Section 658.40(4), Florida Statutes.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be one (1) share. Such share shall be of a single class and shall have a par value of \$1.00 per share. The corporation shall begin business with at least \$1.00 in paid-in-capital stock to be divided into one (1) share. The amount of surplus with which the corporation will begin business will not be less than \$9.00 and the amount of undivided profits, not less than \$9.00 all of which (capital stock, surplus, and undivided profits) shall be paid in cash.

ARTICLE IV

The term for which said corporation shall exist shall be one (1) year.

ARTICLE V
