The undersigned, for the purpose of forming a corporation under
the Florida General Corporation Act hereby adopt the following
Articles of Incorporation.

ARTICLE 1 - NAME OF CORPORATION

The name of this corporation shall be FREEDOM INC.

ARTICLE 2 - GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this
corporation shall be:

- A. To engage in every phase and aspect of any business to the public
under the laws authorized to render.
- B. To invest the funds of this corporation in real estate, mortgages,
stocks, bonds, or any other type of investment and to own real and
personal property necessary for the rendering of such professional services.
- C. To do anything necessary and proper for the accomplishment or
furtherance of any of the purposes or objectives of the corporation
enumerated in these Articles of Incorporation or any amendment thereof,
and to do any act necessary or incidental to the protection and benefit of the

D. It is intended that this corporation may conduct and transact any business lawfully authorized and not prohibited by Chapter 607, Florida Statutes, or other laws of the State of Florida.

ARTICLE 3 - CAPITAL STOCK

C. To enter into, for the benefit of its employees, one or more of the following : (1) a pension plan, (2) a profit sharing plan, (3) a stock bonus plan, (4) a thrift and savings plan, (5) a restricted stock option plan, or (6) any other retirement or incentive compensation plan.
