

ARTICLE ONE- NAME

SECRETARY OF STATE

The name of this corporation is SCOTT TRAVEL & CONSULTANTS
INTERNATIONAL CORPORATION

ARTICLE TWO – PRINCIPAL ADDRESS/MAILING ADDRESS

The Principal Place of business for this corporation is 1900 Land of Lake Blvd., Lutz, Florida 33549. The mailing address of this corporation is 23622 Calabasas Road #301, Calabasas, California 91302.

ARTICLE THREE – PURPOSE & DURATION

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Florida other than the banking business, the trust company business or the practice of a professional permitted to be incorporated by the Florida Corporations Code. This Corporation shall exist perpetually, commencing as of the date of execution of these Articles.

ARTICLE 6 – REGISTERED AGENT






