Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, **PUPELLO & LOPEZ-CUENCA, M.D.S, P.A.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I  
NAME
