ARTICLE I-NAME

The name of this corporation is MENTAL HEALTH ASSOCIATES, INC.

ARTICLE-II-DURATION

This corporation shall have perpetual existence commencing on December 12:00 A.M. after the filing of these Articles with the Department of State.
