ARTICLES OF INCORPORATION OF PENINSULAR LIFE INSURANCE COMPANY

The undersigned incorporators to these Articles of Incorporation, natural persons over the age of 18 years, competent to contract and the majority of whom are citizens of the United States of America, hereby form a stock insurer corporation under the laws of the State of Florida.

ARTICLE I. - NAME

The name of the corporation shall be **PENINSULAR LIFE INSURANCE COMPANY**. The principal place of business of this corporation shall be 600 Courtland Street, Suite 400, Orlando, Orange County, Florida 32804-1352.

ARTICLE II. NATURE OF BUSINESS

The purpose of the corporation is to engage in every aspect of life insurance as defined in Florida Statutes Section 624.602 and health insurance as defined in Florida Statutes Section 624.603.

ARTICLE III. CAPITAL STOCK

The Corporation shall not begin transacting business unless it achieves a capital and surplus of \$2.5 million. The authorized capital stock of this corporation shall be \$16.2 million, divided into 7.2 million shares of stock of the par value of \$2.25 each.
