# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PENINSULAR LIFE INSURANCE COMPANY

Pursuant to the provision of Florida Statute 607.1066, the undersigned corporation (the "Company") adopts the following Articles of Amendment to the Articles of Incorporation, which have the effect of changing the Statutory Home Office Address from 600 Courtland Street, Orlando, Florida to 1001 Heathrow Park Lane, Lake Mary, Florida:

#### ITEM I:

ARTICLE I of the Company's Articles of Incorporation be and hereby is afficing to read as follows:

The name of the Company shall be Peninsular Life Insurance Compa

## ITEM II:

ARTICLE V of the Company's Articles of incorporation be and hereby is amended to read as follows:

The location of the principal office of the Corporation in the State of Florida shall be in the City of Lake Mary, Seminole County, Florida, with power in the Corporation to establish and maintain offices at such other places within or without the State of Florida and within or without the United States as the Board of Directors of the Corporation may, from time to time, determine. The Street address in Florida of the principal office of the Corporation is 1001 Heathrow Park Lane, Lake Mary, Florida 32746 in Seminole County.

## ITEM III:

This amendment to the Articles of Incorporation was adopted by the Board of Directors of the Company on July 26, 2004, subject to the approval of the shareholders. There were 7,200,000 shares of common stock of the Company outstanding, entitled to vote on the approval of this amendment, all of which were held by a single shareholder. The sole shareholder approved this amendment on July 26, 2004.
