To whom it may concern:

On or about December 28th of 2000, my contracted attorney formed this corporation for me. I did not receive my Tax ID number until sometime in April of 2001 due to my status in the country as a foreigner, according to my attorney. I did not start using the corporation until April 2001 when I received my Tax ID number and opened a bank account.

On or about January of 2001 I had sent in my change of address (copy enclosed) from apartment C-111 to apartment C-1903. I recently received a Notice of Administrative Dissolution or Revocation placed in my mailbox, but, addressed to C-111. This is the first notice I receive that advises me that I had the responsibility of filing a 2001 Uniform Business Report on a Corporation that had not been able to operate until April of 2001 as a result of the non-issuance of a Federal Tax ID number.

I hereby request, for a second time, that you change your records to reflect my correct address and that my corporation be reinstated at no additional cost to me in that the corporation was formed 10 months ago and was unusable until April of this year. Alternatively, I request that the department look at these unusual circumstances and grant me the reinstatement for the original \$150 in that I could have attended to the matter timely had I had knowledge of the requirement regardless of my foreigner status not familiar with the laws.

Please advise as to your position on this matter as soon as possible.
