

# ARTICLES OF INCORPORATION OF

SECHLIGARY OF STATE TALLAHASSEE, FLORIDA

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

#### ARTICLE I

The name of the Corporation ("Corporation") is New Age Painting Services, Inc.

#### ARTICLE II

The existence of the Corporation shall be the date on which it is legally formed.

ARTICLE III
