

The name of this corporation is: COMPUTER POWER PLUS, INC

**ARTICLE II - Duration:**

This corporation shall have perpetual existence commencing on the date of this filing of those Articles with the Department of State.


**ARTICLE IX - Indemnification:**



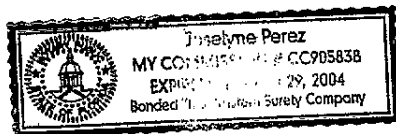


