ARTICLES OF INCORPORATION OF SHARON ROBERTS HENDERSON, P.A.

ARTICLE I.

NAME

The name of this corporation is SHARON ROBERTS HENDERSON, P.A.

ARTICLE II.

PURPOSE

This corporation is organized for the purpose of rendering professional legal services and engaging in and transacting all other business not in conflict with said purpose as may be permitted under the laws of the State of Florida.

ARTICLE III.

PROFESSIONAL CORPORATION RESTRICTIONS

This corporation shall be a professional corporation governed by the provisions of Chapter 621, Florida Statutes. This corporation shall not issue its capital stock to anyone other than an individual who is duly licensed or otherwise legally authorized to render professional legal services. If any officer, shareholder, agent or employee of this corporation who has been rendering professional service to the public becomes legally disqualified to render such professional services within this state or accepts employment that, pursuant to existing law, places

restrictions or limitations upon that person's continued rendering of such professional services, that person shall sever all employment with, and financial interests in, this corporation forthwith.

ARTICLE IV.

PRINCIPAL OFFICE

ARTICLE V.

COMMENCEMENT OF EXISTENCE

The existence of the corporation shall commence on January 1, 2001.
