FIRST: The Board of Directors of each of the constituent corporations has adopted an agreement and plan of merger setting forth the terms and conditions of the merger of such corporations.

SECOND: The name of the domestic constituent corporation, which is to be the surviving corporation, is FUJIFILM Medical Systems U.S.A., Inc.
