Midwest ATC Service would like to request abatement of the reinstatement fee for the following reason:

I am the person responsible for filing all corporation annual reports. However, in November of 1997, I took a leave of absence. During my hiatus, the individual who took over the responsibility of filing taxes quit working here in July, giving us no notice, at which time I returned. I was completely unaware that, although all other state returns had been filed, Florida's had not. We did not receive any prior notification to that effect from the State of Florida before receiving this application for reinstatement. I apologize for this error, and had I realized this report had not been filed, would have taken corrective action immediately.
