ARTICLES OF INCORPORATION

OF

NEW BEGINNINGS FURNITURE, INC.

ARTICLE I - NAME

The name of the corporation is **NEW BEGINNINGS FURNITURE**, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved according to law.
