My corporation is called Redneck World Inc., it's a chapter S Fl. Corp.

I was visiting my attorney yesterday and he asked me if I had submitted my Business Report filing fee, and I said that I had not. I've never received a notification. I understand that the filing fee is \$61.25 and the supplemental Corporate Fee is \$88.75 for a total of \$150.00 and that if this amount is not received by May 1st. a huge penalty is tacked on.

If notice was sent to me, what address was it sent to? Ours is 4915 Baymeadows Rd. Suite 13 B Jacksonville, Fl. 32217

Please note that the suite letter is important because # 13 includes separate addresses A, B, C, & D. I've often not received mail when the letter B was not added after the number 13.

The bottom line is that I did not receive any notice. I most certainly would have paid the fees on time rather than incur the very substantial late penalties.

I respectfully request that because of this circumstance, that I'll be allowed to pay the regular \$150.00 fee. I'm certainly now on notice not to let it happen again next year.
