Dear Sir or Madam:

This letter is in response to your letter dated July 23, 2001 whereby you are requesting a late fee of \$400.00.

This is my third letter regarding the late filing of my UBR report. I understand that my request for a waiver on the late fee was denied, due to what seemed like a contradiction between my first two letters. However, let me try and explain one last time so that we can put this UBR report to rest once and for all.

My first letter (in June) stated that my UBR report had been erroneously filed with some other papers and was then discovered and filed in June 2001. However, what I failed to point out was when I had actually received this UBR report. Hence, I wrote a second letter (in July) explaining that I had not even received the report until June (which is the same month I filed it), and offered some other relevant information that was also in the first letter (such as the date I filed my Corporation papers, etc.):

So as you can see, there is no contradiction between my first two letters. Only that I had left out an important piece of information regarding when I received the UBR report. I am not trying to falsely get out of paying a late fee. This UBR was received late, filed with some other papers, discovered, and then filed. But, it all happened within the same month. I do not understand how I can be penalized for something that was out of my control. So I ask again, due to the above circumstances, please waive the \$400.00 late fee.
