**ARTICLES OF INCORPORATION**

The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME AND ADDRESS**

The name of the Corporation shall be Kerry H. Haskins, M.D., P.A., (the "Corporation"). The address of the principal office of the Corporation shall be 5002 Davenshire Way, Tampa, Hillsborough County, Florida, 33647 and the mailing address shall be the same.

**ARTICLE II. CAPITAL STOCK**

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one hundred thousand (100,000) shares of common stock having a par value of \$0.01 per share.

## **ARTICLE VI. INITIAL DIRECTOR**

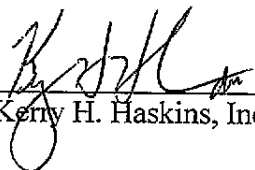

## **ARTICLE VII. PROFESSIONAL CORPORATE ORGANIZATION**

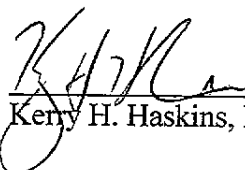
