ARTICLE ONE

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any

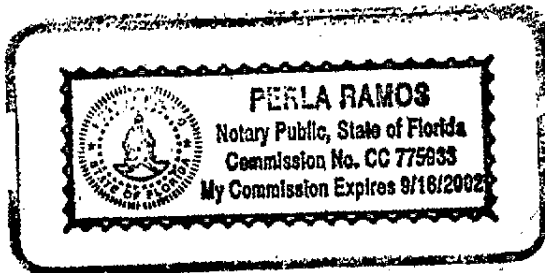
