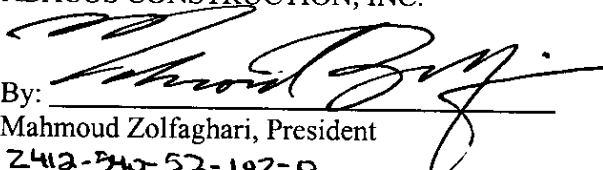
1. Mahmoud Zolfaghari is the President of ABACUS CONSTRUCTION, INC., a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on October 4, 2002.
