ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this corporation is MasTec FC, Inc. (the "Corporation") and its business mailing address is 3155 NW 77th Avenue, Miami, Florida 33122.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in activities or business permitted under the laws of the United States of America and the State of Florida.

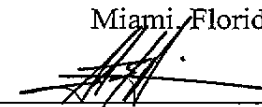

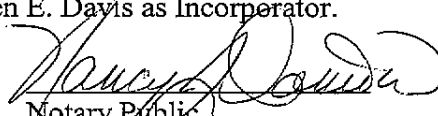

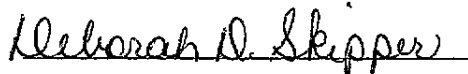
