ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this corporation is MasTec TC, Inc. (the "Corporation") and its business mailing address is 3155 NW 77th Avenue, Miami, Florida 33122.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.


