The undersigned, for the purpose of forming a Professional Service Corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopt the following articles of incorporation:

FIRST: The name of this Corporation is GLENN J. LOSASSO, D.D.S., P.A.

SECOND: This corporation shall exist perpetually, commencing on the date these Articles of Incorporation are filed with the Secretary of State.

THIRD: This corporation is organized to render the practice of dentistry to the public, which shall consist of the actual diagnosing, treating, prescribing, or operating in any degree, or professing or attempting to diagnose, treat, prescribe or operate for, any disease, pain, deformity, deficiency, injury or physical condition of the human tooth, teeth alveolar process, gums or jaws, or their dependent tissues. This professional corporation shall exist and function in compliance with the "*Professional Service Corporation and Limited Liability Company Act*" and in order to properly prosecute the objects and purposes above set forth, the corporation shall have full power and authority to purchase, lease and otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, necessary for the rendering of the service of the practice of dentistry.

FOURTH: This corporation is authorized to issue Five Thousand (5,000) Shares of One

dollar (\$1.00) par value common stock, which shall be designated "common stock".

FIFTH: Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding stock.

SIXTH: The principal office and mailing address of the corporation is 2020 Highway A1A, Suite 105, Indian Harbour Beach, FL 32937.

SEVENTH: The street address of the initial registered office of this corporation is 2020 Highway A1A, Suite 105, Indian Harbour Beach, FL 32937 and the name of the initial registered agent of this corporation at that address is GLENN J. LOSASSO.

EIGHTH: This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the bylaws but shall never be less than one. The name and address of the initial director of this corporation is as follows:

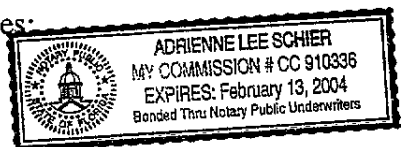

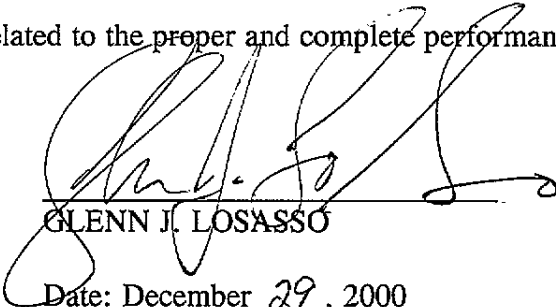
