- B. To invest in real estate, mortgages, stock, bonds, or any other type of investments, or own real and personal property necessary for the rendering of professional services.
- C. The professional services of this corporation is rendered through its members, officers, employees, and agents who are duly licensed or otherwise legally authorized to render such professional services within this state.

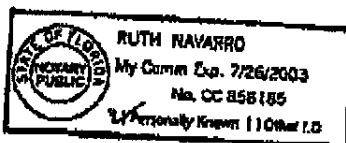
