ARTICLES OF INCORPORATION OF

RICHARD B. LEFFEW, CPA, PA

ARTICLE ONE-NAME

The name of the corporation is Richard B. Leffew, CPA, PA, whose principal office and mailing address is 80 Royal Palm Pointe, Suite 202, Vero Beach, Fl 32960-4227.

ARTICLE TWO-PURPOSE

This corporation is organized for the purpose of providing accounting, auditing, consulting and tax services as permitted by the State of Florida.

ARTICLE THREE-CAPITAL STOCK
