I represent Vitelsa Glass Industries, Inc. (the "Corporation"). This letter is in response to your letter dated November 8, 2002 (the "Letter"), a copy of which is enclosed with this letter. For the reason stated below, I respectfully request that the Corporation be reinstated and that the balance due of \$600 be abated.

The UBR for the Corporation was mailed on April 29, 2002 with the corresponding renewal fee. The UBR was received and your office deposited the check to cover the renewal fee. Further, Ms. Amparo Gonzalez had correspondence via e-mail with your office and received and e-mail (copy attached) stating that the UBR was filed on June 25, 2002.

To Ms. Gonzalez surprise, she received the Letter stating that the UBR was returned on June 18, 2002 and July 17, 2002. Ms. Gonzalez never received the letters and, it would be unfair for the Corporation to pay the \$600 reinstatement fee after Mr. Gonzalez was advised by your office that the UBR was filed and the Corporation was in good standing.
